Signing of the 2018 Wage Ordinance: A motion was made by Richard to accept the 2018 Wage Ordinance with a three percent increase for all employees, seconded by Joyce.

Signing of Additional Appropriations for the Community Crossing Grant: A motion to accept the additional appropriations was made by Joyce, seconded by Richard.

Jim Rogers & Ted Lobdell from Sun Publishing: Jim and Ted came to provide us with up-to-date drug awareness and safety educational materials for our community. They asked the council to partner with them by becoming a sponsor in the amount of \$159.00. to the S.U.N. a Community Awareness Magazine. Richard made a motion that we pay The S.U.N. in the amount \$159.00, seconded by Joyce.

<u>Community Crossing Grant — Street Paving:</u> Richard made a motion to remove the two month time limit on the bidder's package for the street paving. Bryan made the motion to remove the time limit, seconded by Joyce.

<u>Duke-LED Lighting:</u> Richard reported there will be an additional light pole put on Shady Lane. We have an additional twelve lights that need to be added to our contract. The cost will be \$2.20 a month more on a contract for ten years. Richard made a motion to sign an additional contract for the twelve lights, seconded by Joyce.
