# From the Floor:

Corey Ross requested permission to connect to the water/wastewater at 402 W. Washington St. Corey discussed rezoning the property to R-1 and also requested a letter of permission from council to be provided to the Decatur county zoning board per their request. Joyce volunteered to write the letter of permission and approved the request, seconded by John. Vote 3:0

Amanda Organist announced the FOP Lodge 104 Fundraising event that is scheduled on September 19<sup>th</sup> from 4pm – 7pm which includes a free-will donation dinner.

There was discussion regarding the speed limit in town and John asked Damon Land to look into options to reduce speed on Main St. and Dean St.

Town Attorney, Scott Andrews answered questions regarding what happens when town residents refuse to accept certified letters regarding Ordinance violations. Andrews suggested that the town take residents to small claims court to obtain fines, file liens on property or have papers served by the Town Marshall. Andrews also presented an Ordinance to the council to address the Fire Hydrant Issue that was cited by State Board of Accounts in 2019.
